What does the fund invest in?

This segregated fund currently invests in Mackenzie Cundill Canadian Balanced Fund (the "underlying fund"). The underlying fund seeks long-term capital growth by investing mainly in Canadian equities and fixed-income securities. The underlying fund's asset mix will generally range between 60%-70% equities and 30%-40% fixed-income securities and cash and cash equivalents. The underlying fund uses a value style of investing and may hold up to 40% of its assets in foreign investments.



Switching from units of a Mackenzie Segregated Fund or Mackenzie GIF previously purchased under the redemption charge or low-load purchase options to units of another Mackenzie Segregated Fund or Mackenzie GIF, under the same purchase option, will continue to be available until such redemption schedules expire.

2. Ongoing expenses

The MER includes the management fee and operating expenses of the fund. The MER includes the insurance cost for the guarantee. You do not pay these expenses directly. They affect you because they reduce the return you get on your investment. The cost of any additional segregated fund guarantee options is not included in the MER. Trailing commission

Mackenzie pays your advisor a trailing commission of up to 1.0% of the value of your investments for the services and advice provided to you. The trailing commission is paid out of the management fee for as long as you hold the fund. The rate depends on the sales charge option you choose.

3. Other fees

You may have to pay other fees when you redeem or exchange units of the fund.

What if I change my mind?

You can change your mind and cancel the segregated fund policy, the initial pre-authorized chequing premium or any lump sum premium you apply to the policy by telling us in writing within two business days of the earlier of the date you received confirmation of the transaction or five business days after it was mailed to you. Your cancellation request has to be in writing, which can include email, fax or letter, that you want to cancel. The amount returned will be the lesser of the amount of the premium being cancelled or the value of the applicable units acquired on the day we process your request, if it has gone down. The amount returned only applies to the specific transaction and will include a refund of any sales charges you paid. No fees will apply to process your request.
